The 2SK2478 is N-Channel MOS Field Effect Transistor designed for high voltage switching applications.





Test Circuit 2 Switching Time




Test Circuit 3 Gate Charge







TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH








DRAIN TO SOURCE ON-STATE




DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE







GATE TO SOURCE CUTOFF VOLTAGE vs. CHANNEL TEMPERATURE





